TERMS AND CONDITIONS

You will receive a payment of £300 as a bonus in addition to receiving 100% of your compensation awarded, subject to the following terms and conditions: -

1. You agree to instruct pabla+pabla solicitors and provide us with accurate instructions in relation to your accident together with any further information that we may request in order to pursue your claim
2. pabla+pabla solicitors agree to accept your claim
3. No other Solicitor has been instructed previously for your claim
4. You must enter into a Conditional Fee Agreement with us ("No Win No Fee" Agreement)
5. The personal injury claim must be valued at more than £1000.00
6. Liability is admitted by the third party
7. There are no allegations of fraud
8. You must instruct pabla+pabla solicitors directly, and not through a Ministry of Justice regulated body
9. Only one bonus payment is payable per claim
10. The third party must be traced

IMPORTANT – The bonus payment may become repayable if you do not meet all of the above terms and conditions or if you provide misleading information or do not co-operate with your claim.

FREQUENTLY ASKED QUESTIONS

When do I receive my bonus payment of £300?

We will pay you £300 within 14 days of an admission of liability by the fault party's insurers, if you quoted "BONUS 300" when you first contacted us.

Will the £300 be deducted from any compensation that I receive for my injuries?

No, we guarantee that you will receive 100% of the compensation awarded.

Is the up-front bonus payment of £300 legal?

Yes, the Solicitors Code of Conduct deals with the way in which we can pay a third party, such as a claims management company to refer a client to us. However, those rules do not restrict us in making a payment directly to a client who has suffered losses due to an accident.
